10. (1) The joining fee is \$5.00 (or such sum as is determined by the Committee from time to time) and shall be payable by all new senior members but will not apply to junior members until such time as he or she becomes eligible for senior membership and in such cases shall be payable at the beginning of the following financial year.
- (2) The annual membership fee is \$25.00 per annum for senior members and \$1.00 per annum for junior members (or such sum as determined by the Committee from time to time) and shall be payable in advance on the 15th July in each year, provided that any nominee applying for membership at or after a meeting in May will not be liable for a subscription in respect of the current year.
- (3) Any person whose membership fee is more than three (3) months in arrears shall be deemed to have resigned from the Society and shall have forfeited all rights of membership.
